To: All Plan Participants, Beneficiaries and Alternate Payees

The Trustees of the **Central Illinois Carpenters Retirement Savings Fund** ("Fund") wish to notify you of the following changes to the provisions of the Fund's Retirement Savings Plan.

EFFECTIVE NOVEMBER 1, 2023:

The "Missing Participants or Beneficiaries & Forfeited Benefits" section of the Summary Plan Description was amended to read as follows:

Missing Participants or Beneficiaries & Forfeited Benefits

If the Fund is unable to locate you or your beneficiary and obtain a written application from you or your beneficiary before you attain or would have attained the Required Beginning Date as defined in the Plan or before a distribution is due to a beneficiary pursuant to the terms of the Plan Document, then your benefit and/or your beneficiary's benefit, as appropriate, shall be forfeited.

The forfeited benefit shall be frozen and shall not accrue earnings or interest income, but shall be assessed expenses. The Fund shall maintain the frozen forfeited benefit in your Account, and such benefit shall be reinstated if a claim is made by you or your beneficiary for the forfeited benefit.

In the event that you or your beneficiary cannot be located upon termination of the Plan, any amount payable to you or your beneficiary shall be transferred pursuant to applicable law and guidance. Upon such transfer, the Trustees shall have no further liability for the amount so transferred.

The Fund shall make diligent attempts to locate you or your beneficiary in accordance with the Plan's policies. <u>The Fund may charge a Participant's account for reasonable expenses incurred in attempting to locate the</u> <u>Participant or beneficiary</u>.
